Introduction

The following is the Annual Report of the Kensington-Talmadge Planning Group (KTPG). For the period covered by this report (April 2023-March 2024) the officers were David Moty, Chair; Brian Helmich, Vice-Chair; David Roth, Secretary; Lisa Sinclair, Treasurer.

The planning group maintained standing subcommittees for Project Review, and the Kensington Maintenance Assessment Districts: Kensington Heights, Kensington Manor, Kensington Park North, Talmadge Park North, and Talmadge Park South, and the following ad hoc subcommittees: CIP & Planning, Communications, Historic Review, Transportation, Website Update and Elections.

Administrative Issues

Eight regular meetings of the full board were held during the twelve months from April 2023 through March 2024. No regular meetings were held in August and September of 2023, and January and March of 2024. Special meetings were held on February 24, and March 2, 2024.

There is no differentiation made in membership between residents, renters, property owners, or business or non-profit owner/operators, nor are there any seats specifically assigned for large institutional entities.

In June 2023, the Planning Group purchased liability insurance for \$325, as requested by the YMCA in order to hold meetings at their facility as the YMCA would not accept the City's promise of self-indemnification. In July 2023, the YMCA informed the planning group that a notice of liability waiver would have to be signed by every attendee at the planning group meetings. In September 2023, the City informed the planning group that signing such a liability waiver was a de facto sign-in requirement, and was contrary to City policy. The planning group began searching for a new meeting location. In February 2024, the planning group began meeting at the Kensington Community Church.

Community Plan Preparation and Implementation

No community plan amendments were enacted between April 2023 and March 2024. However, the chairs of the City Heights, Eastern Area, Kensington-Talmadge and Normal Heights planning groups formed a joint Community Plan Update Committee in April 2023. It met 7 times from April through March, during which it added members from the Adams Avenue Business Association, El Cajon Boulevard Business Improvement Association and the City Heights Business Improvement District.

Special Projects

June 2023 – At the June meeting, the planning group agreed to circulate a 9 item list of capital improvement projects to the community for their input. At the July meeting, the planning group approved a list of 5 projects, prioritized in order, for input into the City's capital improvement priority survey. By that point, the City's survey had been changed from previous years, and was no longer oriented towards accepting community planning group input.

October 2023 – Proponents of the Talmadge Park Estates Historic District and a Kensington historic district made presentations to the board.

November 2023 – City staff made a presentation on the upcoming Mid-City Communities Plan update. Board member Vito Spano resigned effective November 12.

December 2023 – The planning group approved its submission to the City of an application to continue representing the communities of Kensington and Talmadge.

February 2024 – The planning group approved revisions to its submission as requested by City staff. The planning group also approved assessment recommendations for 4 of the 5 Kensington MADs, Kensington Park North excepted.

March 2024 – Board member Paul Kruger resigned effective March 31.

Historic Review – Through the course of the planning group year, the 45 Year Review liaison received XX permits for potential historic review and requested city staff investigate XX properties for historicity.
