Action Item: Approve/Disapprove five subcommittee recommendations regarding Kensington parking and transportation related issues in the area surrounding Adams Avenue between Alder on the north and Madison on the south, from SR-15 to Van Dyke Avenue.

- 1) Extensive curb restriping along Adams Avenue from SR-15 on the west to Van Dyke on the east, up to one block north/south in some locations; (vote 7-0 in favor)

- 5) Add or relocate USPS mail box at Adams & Edgeware, south side. (vote 7-0 in favor)
